The City Council of the City of Mayfield, Kentucky, met in a special called meeting on Monday, February 10, 2020 at 6:00 p.m. at City Hall, Mayfield, Kentucky. Councilmember Brad Rodgers led the council in prayer.

Councilmember Carol Todd led the council in the pledge to the American flag.

Lauren O Carr, 416 Central St, Mayfield KY, with Graves County Health Department, gave her quarterly update on the needle exchange program.

On a motion by Rodgers, seconded by Cox and with Herndon, Parrott, Cox, Myers, Whitnell, McDonald, Jackson, Todd and Rodgers voting yea, and with none voting nay, Council approved the minutes of the January 13,2020 meeting. Motion passed unanimously.

NEW BUSINESS

On a motion made by Jackson, seconded by Myers, with Rodgers, Todd, Jackson, McDonald, Whitnell, Myers, Cox, Parrott, and Herndon voting yea and none voting nay, Council approved on first reading **Ordinance 1-20**, "an ordinance of the City of Mayfield to rezone 1038 N 15th St, Mayfield Kentucky 42066 from R-1 residential single-family zone to M-1 municipal special district zone, and to rezone a building and lot on 1000 block North 15th Street extended, Mayfield Kentucky 42066 from B-1 highway commercial to M-1 municipal special district zone." Motion passed unanimously.

On a motion made by Cox, seconded by McDonald, with Herndon, Parrott, Cox, Myers, Whitnell, McDonald, Jackson, Todd and Rodgers, voting yea and with none voting nay, Council approved on first reading **Fiscal Ordinance 3-19**, an ordinance amending Fiscal Ordinance 2-19 adopting the annual budget and scheduled salaries for the City of Mayfield Kentucky for the fiscal year July 1, 2019 through June 30, 2020. estimating revenues and resources and appropriating funds for the operation of city government. Motion passed unanimously.

On a motion made by Jackson, seconded by Myers, with Rodgers, Todd, Jackson, McDonald, Whitnell, Myers, Cox, Parrott and Herndon voting yea and with none voting nay, Council approved **Resolution 2-1-20**, a resolution to partner with the Graves County Fiscal Court, Mayfield Graves County Tourism Commission and the Graves County Economic Development in profiding funding for a video project to be used for economic and tourism promotion of Mayfield and Graves County. Motion passed unanimously.

On a motion made by McDonald, seconded by Cox with Rodgers, Todd, Jackson, McDonald, Whitnell, Myers, Cox, Parrott and Herndon voting yea and with none voting nay, Council approved **Resolution 2-2-20**, "a resolution adopting and approving the execution of a Municipal Aid Co-op Program Contract between, the incorporated City and the Commonwealth of Kentucky, Transportation Cabinet, Department of Rural and Municipal Aid for the fiscal year beginning July 1, 2020 as provided in the Kentucky revised Statutes and accepting all streets referred to therein as being streets which are a part of the Incorporated
