The City Council of the City of Mayfield, Kentucky, met in a special meeting on March 14, 2024, at 4:29 p.m. at the Mayor's Office. There were present Mayor Kathy O'Nan, City Projects Administrator Justin Carrico and City Clerk Karen Wilson.

Councilmember John Poole led the council in prayer.

OLD BUSINESS

On a motion by Poole, seconded by Adams, with Carr, Parrott, Jackson, Rodgers, Adams, Poole, and Binkley, voting yea, and with none voting nay, council approved on second reading **Ordinance 6-24** an ordinance "rezoning certain parcels of real property within the City of Mayfield from "I-1 Light Industrial to R-2 Multi-Family Residential." (Parcel ID Numbers: 206.01.09.009.00, 206.01.09.010.00, 206.01.09.011.00 & 206.01.09.012.00) Motion passed unanimously.

NEW BUSINESS

On a motion by Carr, seconded by Jackson, with Binkley, Poole, Adams, Rodgers, Jackson, Parrott and Carr voting yea, and with none voting nay, council passed on first reading **Ordinance 7-24** an ordinance "authorizing the transfer of funds into a money market account for the purchase of real property by the Mayfield Kentucky Industrial Development Authority for economic development purposes." Motion passed unanimously.

Councilmember Nate Cox and City Attorney Jay Matheny arrived at 4:32 p.m.

On a motion by Jackson, seconded by Rodgers, with Carr, Parrott, Cox, Jackson, Rodgers, Adams, Poole and Binkley voting yea, and with none voting nay, council passed on first reading **Ordinance 8-24** and ordinance "authorizing the allocation of up to \$175,000.00 for the purchase of real property by the Mayfield Kentucky Industrial Development Authority for economic development purposes." Motion passed unanimously.

On a motion by Jackson, seconded by Parrott, with Binkley, Poole, Adams, Rodgers, Jackson, Cox, Parrott and Carr voting yea, and with none voting nay, council passed on first reading **Ordinance 9-24** an ordinance "authorizing the allocation of up to \$535,000.00 for the purchase of real property by the Mayfield Kentucky Industrial Development Authority for economic development purposes." Motion passed unanimously.

The time for a special called meeting was set for Monday, March 18, 2024, at 4:30 p.m.

With no further business to come before the Council, on a motion by Adams, seconded by Parrott, the meeting was adjourned at 4:35 p.m.
