Councilmember Nate Cox led the council in prayer.

On a motion by Adams, seconded by Rodgers and with Herndon, Parrott, Cox, Myers, Whitnell, McDonald, Jackson, Todd, Adams and Rodgers voting yea, and with none voting nay, Council approved the minutes of the April 13, 2020 meeting. Motion passed unanimously.

OLD BUSINESS

On a motion made by McDonald, seconded by Rodgers, with Herndon, Parrott, Cox, Myers, Whitnell, McDonald, Jackson, Adams, Todd and Rodgers voting yea and with none voting nay, Council approved on second reading **Fiscal Ordinance 1-20**, an ordinance amending Fiscal Ordinance 2-19 adopting the annual budget and scheduled salaries for the City of Mayfield Kentucky for the fiscal year July 1, 2019 through June 30, 2020. estimating revenues and resources and appropriating funds for the operation of city government. Motion passed unanimously.

NEW BUSINESS

On a motion made by Adams, seconded by McDonald, with Herndon, Parrott, Cox, Myers, Whitnell, McDonald, Jackson, Adams and Todd voting yea and with Rodgers voting nay, Council approved on first reading **Fiscal Ordinance 2-20**, "an ordinance adopting the annual budget and scheduled salaries for the City of Mayfield, Kentucky for the fiscal year July 1, 2020 through June 30, 2021 estimating revenues and resources and appropriating funds for the operation of city government." Motion passed nine to one.

On a motion made by Rodgers, seconded by Cox, with Rodgers, Todd, Adams, Jackson, McDonald, Whitnell, Myers, Cox, Parrott and Herndon voting yea and with none voting nay, Council approved **Resolution 5-1-20**, "a resolution adopting and approving the execution of a Municipal Aid co-op Program Contract between the Incorporated City and the Commonwealth of Kentucky, Transportation Cabinet, Department of Rural and Municipal Aid for the fiscal year beginning July 1, 2020, as provided in the Kentucky Revised Statutes and accepting all streets referred to therein as being streets which are a part of the Incorporated City." Motion passed unanimously.

On a motion made by Cox, seconded by McDonald, with Herndon, Parrott, Cox, Myers, Whitnell, McDonald, Jackson, Adams, Todd and Rodgers voting yea and with none voting nay, Council approved **Resolution 5-2-20** "a resolution agreeing to the listed roads on Appendix A are a part of the City road system and those listed on Appendix B are not part of the city road system." Motion passed unanimously. Appendixes are attached to the Resolution.
