CITY COUNCIL MINUTES CITY OF MAYFIELD, KENTUCKY

June 13, 2022

Prior to the city council meeting, the annual Municipal Road Aid hearing was held at 4:30 pm. No one from the community or city council were in attendance for the hearing.

The City Council of the City of Mayfield, Kentucky, met in a regular meeting on June 13, 2022, at 5:02 p.m. at the Purchase Area Development District. There were present Mayor Kathy O'Nan, Fire Chief, Ambulance Director & Community Development Coordinator, Jeremy Creason, Police Chief Nathan Kent, Public Works Director Russ Brower, City Attorney Bo Neely, and City Clerk Tamie Johnson.

Police Chief, Nathan Kent, opened the city council meeting.

Councilmember Barry McDonald led the council in prayer.

Councilmember Johnny Lee Jackson led the council in the pledge to the American flag.

John Poole and David Wright with Fuller Homes addressed council concerning the placement of a camper on 814 S 12th St., for Joe Currin's brother, while he builds a house at that location.

Michael Dick, 338 Chester Lane Mayfield Kentucky, asked the council for a timeline on when Broadway would be open, and the traffic signals would be operational.

Teresa Rochetti Cantrell, 214 Golf Cart Mayfield Kentucky, addressed council concerning the upcoming request to freeze building permits in order to do long range planning for the area of James St to North St.

Ryan Drane with Long Term Recovery gave updates to the council.

On a motion by Carr and seconded by Rodgers, with Carr, Todd, Rodgers, Jackson, Whitnell, McDonald, Parrott, Herndon and Johnny Lee Jackson, voting yea and with none voting nay, Council approved minutes from May 2, May 9 & May 24, 2022, meetings. Motion passed unanimously.

OLD BUSINESS

On a motion by Jackson, seconded by Herndon, with Carr, Rodgers, Jackson, Whitnell, McDonald, Parrott, Todd, Herndon, and Johnny Lee Jackson voting yea and with none voting nay, Council approved on second reading **Ordinance 3-22**, "an ordinance establishing new zoning district to be known as multi-family revitalized residential district (R-4)". Motion passed unanimously.

NEW BUSINESS

Don Costello, chairman of the planning commission addressed council about the recommendation of the planning commission to consider annexation of the street currently known as Treeland Drive.

Mayor O'Nan gave her state of the city address.

On a motion by McDonald, seconded by Jackson, with Johnny Lee Jackson, Herndon, Todd, Parrott, McDonald, Whitnell, Jackson, Rodgers, and Carr voting yea and with none voting nay, Council approved on first reading **Fiscal Ordinance 2-22**, "a fiscal ordinance amending Fiscal Ordinance 2-21 "an ordinance adopting the annual budget and scheduled salaries for the City of Mayfield, Kentucky, for the fiscal year July 1, 2021 through June 30, 2022 estimating revenues and resources and appropriating funds for the operation of city government." Motion passed unanimously.

On a motion by Jackson, seconded by Parrott, with Carr, Jackson, Whitnell, McDonald, Parrott, and Todd voting yea and with Rodgers, Herndon and Johnny Lee Jackson, voting nay, Council approved on first reading **Fiscal Ordinance 3-22**, "an ordinance adopting the annual budget and scheduled salaries for the City of Mayfield, Kentucky, for the fiscal year July 1, 2022, through June 30, 2023, estimating revenues and resources and appropriating funds for the operation of city government." Motion passed six to three.

On a motion by Rodgers, seconded by Parrott, with Johnny Lee Jackson, Herndon, Todd, Parrott, McDonald, Whitnell, Jackson, Rodgers and Carr voting yea and with none voting nay, Council approved **Resolution 6-1-22**, "a resolution to amend the 2021-2022 fiscal year budget for the purchase of a 2022 Ford F250 for public works" Purchase price is \$27,277.00 Motion passed unanimously.

On a motion by Herndon, seconded by Parrott, with Carr, Rodgers, Jackson, Whitnell, McDonald, Parrott, Todd, Herndon and Johnny Lee Jackson voting yea and with none voting nay, Council approved **Resolution 6-2-22** "a resolution requesting an executive order to place a short-term assessment period on certain parts of the City of Mayfield, Kentucky in order to establish new zoning and design standards in order to promote growth and development." Motion passed unanimously.

On a motion by Carr, seconded by Jackson, with Johnny Lee Jackson, Herndon, Todd, Parrott, McDonald, Whitnell, Jackson, Rodgers and Carr voting yea and none voting nay, Council approved **Resolution 6-3-22**, "a resolution to enter into an interlocal agreement with City of Paducah for building inspection and plan review." Motion passed unanimously.

On a motion by Rodgers, seconded by McDonald, with Carr, Rodgers, Jackson, Whitnell, McDonald, Parrott, Todd, Herndon and Johnny Lee Jackson voting yea and with none voting nay, Council approved on an oral resolution to approved Codell Construction as the construction manager for the City of Mayfield projects. Motion passed unanimously.

On a motion by Jackson, seconded by Whitnell, with Johnny Lee Jackson, Herndon, Todd, Parrott, McDonald, Whitnell, Jackson, Rodgers and Carr voting yea and with none voting nay, Council approved on an oral resolution to approve DRC as the debris removal contractor, and Thompson Consulting as the debris monitoring company. Motion passed unanimously.

Reports were given by department heads.

Derrick Parrott left the meeting at 6:22 pm.

With no further business to come before the Council, the meeting was adjourned at 6:41 p.m.
