The City Council of the City of Mayfield, Kentucky, met in a special called meeting on June 13, 2022, at 5:02 p.m. at the Purchase Area Development District. Police Chief, Nathan Kent, opened the city council meeting.

Councilmember Brad Rodgers led the council in prayer.

Councilmember Derrick Parrott led the council in the pledge to the American flag.

Ryan Drane, with Long Term Recovery, gave updates to the council.

Thomas Anderson, 405 N 7th Street, addressed council concerning building permits being frozen following the recent approval of Resolution 6-2-22. Mr. Anderson wishes to build his home back at his current location.

Phillip Anderson, 405 N 7th Street, addressed council concerning his father being unable to obtain a building permit.

Mike Hanover, 1250 St Rt 303, with Hope Initiative, inquired of council as to when the property they were working on would be rezoned, so they could continue their building project.

OLD BUSINESS

On a motion by Adams, seconded by Carr, with Johnny Lee Jackson, Herndon, Todd, Parrott, McDonald, Whitnell, Jackson, Rodgers, Adams, and Carr voting yea and with none voting nay, Council approved on second reading **Fiscal Ordinance 2-22**, "a fiscal ordinance amending Fiscal Ordinance 2-21 "an ordinance adopting the annual budget and scheduled salaries for the City of Mayfield, Kentucky, for the fiscal year July 1, 2021 through June 30, 2022 estimating revenues and resources and appropriating funds for the operation of city government." Motion passed unanimously.

On a motion by McDonald, seconded by Jackson, with Carr, Adams, Jackson, Whitnell, McDonald, Parrott, Herndon, and Todd voting yea and with Rodgers, and Johnny Lee Jackson, voting nay, Council approved on second reading **Fiscal Ordinance 3-22**, "an ordinance adopting the annual budget and scheduled salaries for the City of Mayfield, Kentucky, for the fiscal year July 1, 2022, through June 30, 2023, estimating revenues and resources and appropriating funds for the operation of city government." Motion passed eight to two.

Darin French, Assistant Fire Chief and Safety Officer, reported to council the condition of the playground equipment located in the parks, namely Kess Creek Park.

Jason Lemle, with Graves County Economic Development, presented information to the council concerning TIF districts. It was discussed that a workshop might be called to have more in depth discussions.

With no further business to come before the Council, the meeting was adjourned at 6:00 p.m.
