The City Council of the City of Mayfield, Kentucky, met in a regular meeting on July 11, 2022, at 5:03 p.m. at the Purchase Area Development District. There were present Mayor Kathy O'Nan, Fire Chief, Ambulance Director & Community Development Coordinator, Jeremy Creason, Police Chief Nathan Kent, Public Works Director Russ Brower, Attorney Bo Neely, and Assistant City Clerk Karen Wilson.

Police Chief, Nathan Kent, opened the city council meeting.

Councilmember Chuck Whitnell led the council in prayer.

Councilmember Carol Todd led the council in the pledge to the American flag.

Pastor Stephen Boyken, 241 State Route 1890, with Hope Initiative, requested a special called meeting to vote on **Ordinance 4-22** rezoning a parcel of land from R-2 multi-family residential to R-4 multi-family revitalized residential.

Wendall Guge from Mayfield's American Legion Post 26 honored Justin O'Connor with the American Legion 2022 Kentucky State Firefighter of the Year Award for his efforts at MCP Candle Factory after the December 10th tornado.

Thomas Anderson, 405 N 7th Street, addressed council concerning building permits being frozen following the recent approval of Resolution 6-2-22. Mr. Anderson wishes to build his home back at his current location.

City Attorney Bo Neely addressed the council and audience and reviewed **Resolution 6-2-22** "asking for an executive order to place a short-term assessment period on certain parts of the City of Mayfield, Kentucky in order to establish new zoning and design stands to promote growth and development". He outlined the timeline for the city concerning urban planning and debris removal.

Phillip Anderson, 405 N 7th Street, addressed council concerning his family's wishes to rebuild a home on North 7th Street.

On a motion by Adams and seconded by Rodgers, with Carr, Adams, Todd, Rodgers, Jackson, Whitnell, McDonald, Parrott, and Johnny Lee Jackson, voting yea and with none voting nay, Council approved minutes from the June 13, & June 28, 2022, meetings. Motion passed unanimously.

NEW BUSINESS

On a motion by Carr, seconded by Parrot, with Carr, Adams, Rodgers, Jackson, Whitnell, McDonald, Parrott, Todd and Johnny Lee Jackson voting yea and with none voting nay, Council approved on first reading **Ordinance 4-22**, "an ordinance to rezone 17 parcels of land located between the 300 block of South 10th Street and the 300 block of South 11th Street and running between the 400 block of West Water Street and the 400 block of West Walnut Street from R-2 multifamily residential zone to R-4 multi-family revitalized residential." Motion passed unanimously.

Reports were given by department heads.

The Council discussed buying playground equipment for Kess Creek Park with the donated tornado funds the city received.

The Council agreed to have a special called meeting on Friday, July 15, 2022, at 5:00 p.m. at the Purchase Area Development District to vote on the second reading of Ordinance 4-22.
