The City Council of the City of Mayfield, Kentucky, met in a regular meeting on August 8, 2022, at 5:03 p.m. at the Purchase Area Development District. There were present Mayor Kathy O'Nan, Fire Chief, Ambulance Director & Community Development Coordinator, Jeremy Creason, Police Chief Nathan Kent, Public Works Director Russ Brower, Attorney Bo Neely, and City Clerk Karen Wilson.

Police Chief, Nathan Kent, opened the city council meeting.

Councilmember Johnny Jackson led the council in prayer.

Mayor Kathy O'Nan led the council in the pledge to the American flag.

Mayor Kathy O'Nan presented Coach Joe Morris from Mayfield High School the key to the city and named him a Most Honored Citizen of Mayfield.

Mayor Kathy O'Nan presented Karen Wilson as her appointee for the office of City Clerk.

On a motion by Adams and seconded by Rodgers, with Carr, Adams, Todd, Rodgers, Jackson, Whitnell, McDonald, Parrott, and Johnny Lee Jackson, voting yea and with none voting nay, Council approved the appointment of Karen Wilson as the new City Clerk. Motion passed unanimously.

Mayor Kathy O'Nan provided an update on the progress of debris removal.

On a motion by Rodgers and seconded by Adams, with Carr, Adams, Todd, Rodgers, Jackson, Whitnell, McDonald, Parrott, and Johnny Lee Jackson, voting yea and with none voting nay, Council approved minutes from the July 11, July 15, & July 26, 2022, meetings. Motion passed unanimously.

NEW BUSINESS

Mayfield Planning Commission presented a zoning change request--Vacant lot, parcel #106.00.00.055.00, from B-1 Highway Commercial to R-2 Multi-Family, located in the 1000 block of Commonwealth Drive, Mayfield, Ky 42066. The parcel number was incorrectly identified in the previous zoning change request.

On a motion by McDonald, seconded by Jackson, with Carr, Adams, Rodgers, Jackson, Whitnell, McDonald, Parrott, Todd, and Johnny Lee Jackson voting yea and with none voting nay, Council approved on first reading **Amended Ordinance 5-22**, "an ordinance to rezone a vacant lot, parcel #106.00.00.055.00 from B-1 Highway Commercial to R-2 Multi-Family, located in the 100 block of Commonwealth Drive, Mayfield, KY 42066." Motion passed unanimously.

On a motion by Johnny Lee Jackson and seconded by Rodgers, **Resolution 8-1-22** was tabled due to incorrect information contained within the resolution.

On a motion by McDonald, seconded by Adams, with Johnny Lee Jackson, Parrott, Adams, McDonald, Whitnell, Jackson, Rodgers, Todd, and Carr voting yea and with none voting nay, Council approved an **Oral Resolution** "a resolution for Codell Construction to solicit bids for the demolition of fire station #1." Motion passed unanimously.

Reports were given by department heads.

City Attorney Bo Neely gave an update on debris removal.

City Attorney Bo Neely discussed the formation of an Industrial Authority for the City of Mayfield. He asked the Council to contact him if they were interested in the formation of the Industrial Authority so appropriate legislation could be prepared.

With no further business to come before the Council, the meeting was adjourned at 6:21 p.m.
