The City Council of the City of Mayfield, Kentucky, met on Monday, August 12, 2019 at 6:00 p.m. at City Hall, Mayfield, Kentucky. On a motion by Jackson, seconded by Adams, and with Summers, Cox, Myers, Whitnell, McDonald, Jackson, Adams, Todd and Rodgers voting yea, and with none voting nay, Council approved the minutes of the July 12, 2019 meeting. Motion passed unanimously.

NEW BUSINESS

On a motion made by Cox, seconded by McDonald, with Summers, Cox, Myers, McDonald, Jackson, Adams, Todd and Rodgers voting yea and with Whitnell voting nay, Council approved on first reading **Ordinance 4-19**, "an ordinance of the City of Mayfield, Kentucky adopting with amendments found herein to ordinance 24-16 and rescinding ordinance 37-17 accordingly." Motion passed eight to one.

Councilmember Adams left the council chambers at 7:01.

On a motion made by McDonald, seconded by Rodgers, with Rodgers, Todd, Jackson, McDonald, Whitnell, Myers, Cox and Summers voting yea and with none voting nay, Council approved **Ordinance 5-19**, "an ordinance amending ordinance

43-16, chapter 13, planning & development, section 401, by updating schedule of fees and adopting the state of Kentucky's building permit fees." Motion passed unanimously.

Councilmember Adams returned to the council chambers at 7:03

On a motion made by Cox, seconded by Rodgers, with Summers, Cox, Myers, Whitnell, McDonald, Jackson, Adams, Todd and Rodgers, voting and with none voting nay, Council approved **Resolution 8-1-19**, "a resolution giving an additional \$5,000 to the Mayfield Graves County Parks and Recreation Board and amending the 2019-2020 fy budget. Motion passed unanimously.

On a motion made by Adams, seconded by Cox, with Rodgers, Todd, Adams, Jackson, McDonald, Whitnell, Myers, Cox, and Summers, voting yea and with none voting nay, Council approved with corrections (changing the amount to \$7,930.00) **Resolution 8-2-19**, "a resolution amending the 2019-2020 fy budget for unforeseen master commissioner foreclosure cost." Motion passed unanimously.

On a motion made by Cox, seconded by Rodgers, with Summers, Cox, Myers, Whitnell, McDonald, Jackson, Adams, Todd, and Rodgers, voting yea and with none voting nay, Council approved **Resolution 8-3-19**, "a resolution to amend the 2019-2020 budget to replace the server and two CPU's in the Clerk's office, the purchase amount to be \$9,500.00. Motion passed unanimously.

On a motion made by Myers, seconded by Adams, with Rodgers, Todd, Adams, Jackson, McDonald, Whitnell, Myers, Cox and Summers, voting yea and with none voting nay, Council approved **Resolution 8-4-19**, " a resolution declaring property as surplus." Motion passed unanimously.

On a motion made by Myers, seconded by Whitnell, with Summers, Cox, Myers, Whitnell, McDonald, Jackson, Adams, Todd and Rodgers, voting yea and with none voting nay, Council approved **Resolution 8-5-19**, "a resolution allowing the mayor to seek bids for demolition and replacement of the current public works building." Motion passed unanimously.

On a motion made by Whitnell, seconded by Jackson, with Rodgers, Todd, Adams, Jackson, McDonald, Whitnell, Myers, Cox, and Summers voting yea and with none voting nay, Council approved **Resolution 8-6-19**, "a resolution to amend the 2019-2020 fy budget to donate \$1,000 to the Mayfield Graves County Census Committee to help increase awareness. Motion passed unanimously.

On a motion made by Cox, seconded by Adams, with Summers, Cox, Myers, Whitnell, McDonald, Jackson, Adams, Todd and Rodgers, voting yea and with none voting nay, Council approved **Resolution 8-7-19**, "a resolution to transfer the deed to 418, 422, and 424 W Water Street to Mayfield Neighborhood Development, LLC, for the purpose of neighborhood revitalization." Motion passed unanimously.

On a motion by Summers, seconded by Rodgers, with Rodgers, Todd, Adams, Jackson, McDonald, Whitnell, Myers, Cox and Summers, voting yea and with none voting nay, Council approved **Resolution 8-8-19**, "a resolution to amend the 2019-2020 fy budget by \$5,000 to purchase a digital copier for digitalizing blueprints in the code department." Motion passed unanimously.

On a motion made by Adams, seconded by Jackson, with Summers, Cox, Myers, Whitnell, McDonald, Jackson, Adams, Todd and Rodgers voting yea and with none voting nay, Council approved **Resolution 8-9-19**, "a resolution to foreclose on 311 High Street." Motion passed unanimously.

Monthly reports were given by department heads and councilmembers.

With no further business to come before the Council, the meeting was adjourned at 7:47 p.m.
