CITY COUNCIL MINUTES CITY OF MAYFIELD, KENTUCKY

September 12, 2022

The City Council of the City of Mayfield, Kentucky, met in a regular meeting on September 12, 2022, at 5:02 p.m. at the Purchase Area Development District. There were present Mayor Kathy O'Nan, Fire Chief, Ambulance Director & Community Development Coordinator, Jeremy Creason, Police Chief Nathan Kent, Public Works Director Russ Brower, Attorney Bo Neely, and City Clerk Karen Wilson.

Police Chief Nathan Kent opened the city council meeting.

Councilmember Brad Rodgers led the council in prayer.

Councilmember Carol Todd led the council in the pledge to the American flag.

Michael Dick of 338 Chester Lane, Hickory, Kentucky announced that there would be a forum for all upcoming candidates in the November election. The forum would be held in October at the Purchase Players building.

On a motion by Jackson and seconded by Adams, with Carr, Adams, Todd, Rodgers, Jackson, McDonald, and Herndon voting yea and with none voting nay, Council approved minutes from the August 8, & August 23, 2022, meetings. Motion passed unanimously.

Mayor Kathy O'Nan updated the community on the traffic flow through town and the conclusion of debris removal within the city. She also gave a brief introduction to incentives for businesses locating or relocating in the city.

OLD BUSINESS

On a motion by Rodgers, seconded by Herndon, and with Carr, Adams, Rodgers, Jackson, McDonald, Todd, and Herndon voting yea and with none voting nay, Council approved on second reading **Ordinance 6-22** "an ordinance relating to the establishment of a Local Development Authority pursuant to sections 154.50-301 through and including 154.50-346 of the Kentucky Revised Statutes, as amended ("KRS") to be known as the Mayfield, Kentucky Industrial Development Authority (The "Authority"). Motion passed unanimously.

On a motion by Adams, seconded by Jackson, and with Herndon, Adams, McDonald, Jackson, Rodgers, Todd, and Carr voting yea, and with none voting nay, Council approved on second reading **Ordinance 7-22**, "an ordinance closing a portion of Valley Drive in Mayfield, Kentucky." Motion passed unanimously.

Councilmember Chuck Whitnell arrived at 5:24p.m.

NEW BUSINESS

On a motion by Herndon, seconded by Jackson, and with Carr, Adams, Rodgers, Jackson, Whitnell, McDonald, Todd, Herndon voting yea, and with none voting nay, Council approved the bid of \$18,500.00 by YEC for demolition of Fire Station 1. Motion passed unanimously.

On a motion by Jackson and seconded by McDonald, with Carr, Adams, Whitnell, McDonald, Jackson, Rodgers, Todd, and Herndon voting yea and with none voting nay, Council approved on first reading **Fiscal Ordinance 4-22**, "an ordinance levying an Ad Valorem tax upon all property in the City of Mayfield, Kentucky as applied to the 2022 assessment of taxable property as provided by the Property Valuation Administrator of Graves County." Motion passed unanimously.

On a motion by Adams, seconded by Rodgers, with Todd, Rodgers, Jackson, Whitnell, McDonald, Adams, and Herndon voting yea, and with Carr abstaining, Council approved on first reading **Ordinance 8-22** "an ordinance establishing a payroll tax rebate program for qualified commercial facility developers, property owners and tenants." Motion passed unanimously.

Department Heads gave their monthly reports.

City Attorney Bo Neely gave an update on debris removal and proposed a city wide cleanup day.

With no further business to come before the Council, the meeting was adjourned at 6:09 p.m.
