The City Council of the City of Mayfield, Kentucky, met on Monday, October 8, 2018 at 6:00 p.m. at City Hall, Mayfield, Kentucky. There were present Mayor Teresa Cantrell, Fire Chief Jeremy Creason, Police Chief Nathan Kent, Public Works Director, Russ Brower, Director of Planning and Community Development John Poole, and City Clerk Tamie Johnson.

Councilmember Kathy O'Nan led the council in prayer.

Councilmember Steven Elder led the council in the pledge to the American flag.

Mayor Cantrell read a proclamation declaring October 14-20, 2018, as KY Extension Homemakers Week. The Graves County Homemakers were in attendance for the reading of the proclamation and presented the council and staff with bars of chocolate.

Mayor Cantrell recognized Murphy's Oil, as the business of the month. Tracy Hutchens and Amanda Scott assistant managers were presented with a certificate and sign to place at the business.

Lauren Carr, with ASAP, along with students Elizabeth Abreu, Dulce Cortes, and Tori Doran, updated the council on the latest product, containing nicotine, available to young teens. This item is measured in jules and contains high amounts of nicotine.

OLD BUSINESS

On a motion made by Potts, seconded by Summers, with Summers, Potts, O'Nan, Whitnell Jackson, Myers, Adams, and Elder voting yea and with none voting nay, Council approved on second reading **Fiscal Ordinance 3-18**, "an ordinance levying an ad valorem tax upon all property in the City of Mayfield, Kentucky, as applied to the 2018 assessment of taxable property as provided by the property valuation administrator of Graves County." Motion passed unanimously.

NEW BUSINESS

On a motion made by O'Nan, seconded by Adams, with Elder, Adams, Myers, Jackson, Whitnell, O'Nan, Potts, and Summers voting yea and with none voting nay, Council approved **Resolution 10-1-18**, "a resolution to allocate no more than \$86,625.00 to complete the trial lighting project at Kess Creek Park." Motion passed unanimously.

On a motion made by Adams, seconded by Myers, with Summers, Potts, O'Nan, Whitnell, Jackson, Myers, Adams, and Elder voting yea and with none voting nay, Council approved **Resolution 10-2-18**, "a resolution approving the Jackson Purchase Region Natural Hazard Mitigation Plan as adopted by the regional counties." Motion passed unanimously.

Reports from Department Heads and Committees were given.
