Ryan Drane, with Mayfield Graves County Economic Development, 201 E College, Mayfield KY presented an update on the spec building in the industrial park, Gencanna progress, workforce development as well as a housing development project.

Lauren Carr, with the Graves County Health Department, 416 Central Avenue, Mayfield KY presented the latest statistics concerning the needle exchange program and the distribution of Narcan for drug overdose prevention.

On a motion made by Myers, seconded by Rodgers, with Summers, Parrott, Myers, Whitnell, Jackson, Todd and Rodgers voting yea and none voting nay, Council approved **Resolution 10-1-19**, "a resolution to amend the FY 2019-2020 Budget in the amount of \$4500.00" to replace a copier in the City Clerk's Office. Motion passed unanimously.

On a motion made by Jackson, seconded by Whitnell, with Rodgers, Todd, Jackson, Whitnell, Myers, Parrott and Summers, voting yea and with none voting nay, Council approved **Resolution 10-2-19**, "a resolution declaring property as surplus." Motion passed unanimously.

On a motion made by Jackson, seconded by Myers, with Summers, Parrott, Myers, Whitnell, Jackson, Todd and Rodgers voting yea and with none voting nay, Council approved **Resolution 10-3-19**, "a resolution to amend the FY 2019-2020 Budget to increase the salary schedule across the board for the member of the MFD(excluding the chief's position) in the amount of \$250,000." Motion passed unanimously.
