## CITY COUNCIL MINUTES CITY OF MAYFIELD, KENTUCKY

## July 10, 2023

The City Council of the City of Mayfield, Kentucky, met in a regular meeting on July 10, 2023, at 5:00 p.m. at the Purchase Area Development District. There were present Mayor Kathy O'Nan, City Attorney Representative Lisa Emmons, Police Chief Nathan Kent, Fire Chief, Ambulance Director & Community Development Coordinator Jeremy Creason, Assistant Public Works Director Aaron Blount and City Clerk Karen Wilson.

Police Chief Nathan Kent opened the city council meeting.

Councilmember Justin Carrico led the council in prayer.

Councilmember Nate Cox led the council in the pledge to the American flag.

Jill Celeya of Heart of Mayfield Emerges "HOME" gave a report on the progress the community is making since the tornado.

Councilmember Lauren Carr gave a report on the new substance abuse resource guide.

Mayor O'Nan talked about the new CDBG application process for homeowners who had damage due to the tornado.

Stephen Boyken discussed the progress Hope Initiative has made in constructing houses after the tornado.

On a motion by Poole, and seconded by Adams, with Carrico, Poole, Adams, Whitnell, McDonald, Jackson, Cox, Parrott and Carr voting yea, and none voting nay, council approved the minutes from the June 12, 2023, council meeting. Motion passed unanimously.

## OLD BUSINESS

On a motion by McDonald, seconded by Parrott, with Carrico, Poole, Adams, Whitnell, McDonald, Jackson, Cox, Parrott, and Carr voting yea, and none voting nay, council approved on second reading **Ordinance 5-23** an ordinance "closing a public way located between South 10<sup>th</sup> Street and South 11<sup>th</sup> Street in Mayfield, Graves County Kentucky." Motion passed unanimously.

On a motion by Adams, seconded by Carrico, with Carr, Parrott, Cox, Jackson, McDonald, Whitnell, Adams, Poole, and Carrico voting yea, with none voting nay, council approved on second reading **Ordinance 6-23** an ordinance "approving a memorandum of understanding between the City of Mayfield, Kentucky and Samaritan's Purse with respect to the development of a residential subdivision which is facilitating the public purposes of the city rebuilding residential housing destroyed by the catastrophic tornado of 2021 and authorizing the execution of the memorandum of understanding and other documents related thereto." Motion passed unanimously.

## **NEW BUSINESS**

On a motion by Carr, seconded by Carrico, with Carrico, Poole, Adams, Whitnell, McDonald, Jackson, Cox, Parrott, and Carr voting yea, with none voting nay, council approved on first reading **Ordinance 7-23** an ordinance "closing the portion of East South Street located between South 7<sup>th</sup> Street and South 6<sup>th</sup> Street in Mayfield, Graves County Kentucky."

Motion passed unanimously.

On a motion by Cox, seconded by Poole, with all members voting yea, and none voting nay, the council gave approval for the mayor to sign an Interlocal Agreement with the Graves County Fiscal Court for the purpose of the development of soccer fields on the property known as Kess Creek Park. Motion passed unanimously.

On a motion by Adams, seconded by Cox, with Carrico, Poole, Adams, Whitnell, McDonald, Jackson, Cox, Parrott, and Carr voting yea, and none voting nay, council approved **Resolution 7-1-23** a resolution to surplus a siren control box from the Police Department. Motion passed unanimously.

With all members voting yea, and none voting nay, the council approved a recommendation from the Planning Commission for a zoning change for 209 Compressor Drive, Mayfield, Kentucky from I1 Industrial to B1 Commercial.

Department heads gave their reports.

With no further business to come before the Council the meeting was adjourned at 6:07 p.m.
