

CITY COUNCIL MINUTES CITY OF MAYFIELD, KENTUCKY

October 11, 2021

The City Council of the City of Mayfield, Kentucky, met in a meeting on Monday, October 11, 2021, at 5:15 p.m. at city hall. There were present Mayor Kathy ONan, Fire Chief, Ambulance Director & Community Development Coordinator, Jeremy Creason, Police Chief Nathan Kent, Public Works Director Russ Brower, City Attorney Bo Neely, and Assistant City Clerk Karen Wilson.

Police Chief, Nathan Kent, opened the city council meeting.

Councilmember Darrick Herndon led the council in prayer.

Councilmember Chuck Whitnell led the council in the pledge to the American flag.

Family members of the late mayor and council member Wayne Potts presented the city with a check for \$1000.00 to repair the sign at Lions Club Park. The Lions Club President Colleen Alexander also presented a check for \$500.00 toward the park sign. The new sign will honor the late Mr. Potts.

Mayor O’Nan read a proclamation announcing that the week of October 10th-16th, 2021, would be Kentucky Extension Homemakers week.

On a motion by Adams, seconded by Parrott and with Carr, Adams, Rodgers, Jackson, Parrott, Whitnell, Todd, and Herndon voting yea, and with none voting nay, Council approved the minutes of the September 7, 2021, special called meeting and the September 13, 2021, regular meeting. Motion passed unanimously.

OLD BUSINESS

On a motion made by Adams, seconded by Jackson, and with Herndon, Adams, Rodgers, Jackson, Whitnell, Parrott, Todd and Carr voting yea and with none voting nay, Council approved on second reading **Fiscal Ordinance 3-21**, a fiscal ordinance amending Fiscal Ordinance 2-20 “an ordinance adopting the annual budget and scheduled salaries for the City of Mayfield, Kentucky for the fiscal year July 1, 2020 through June 30, 2021 estimating revenues and resources and appropriating funds for the operation of city government”. Motion passed unanimously.

On a motion made by Whitnell, seconded by Herndon, and with Carr, Adams, Rodgers, Jackson, Whitnell, Parrott, Todd and Herndon, voting yea and with none voting nay, Council approved on second reading **Fiscal Ordinance 4-21**, “an ordinance levying an ad valorem tax upon all property in the City of Mayfield, Kentucky, as applied to the 2021 assessment of taxable property as provided by the property valuation administrator of Graves County”. Motion passed unanimously.

On a motion made by Herndon, seconded by Carr, and with Herndon, Todd, Parrott, Whitnell, Jackson, Rodgers, Adams, and Carr, voting yea and with none voting nay, Council approved on second reading **Ordinance 4-21** “an ordinance of the City of Mayfield, Kentucky, authorizing Mayor Kathy S. O’Nan to execute an agreement with Grabhorn Law Office, PLLC to perform legal services on behalf regarding claims of the City relating to opioid litigation”. Motion passed unanimously.

On a motion made by Carr, seconded by Rodgers, and with Carr, Adams, Rodgers, Jackson, Whitnell, Parrott, Todd, and Herndon voting yea and with none voting nay, Council approved on second reading **Ordinance 5-21** “an ordinance, amending the Code of Ordinances, City of Mayfield Kentucky, Chapter 6, ‘Fire Prevention and Protection,’ section 6-3, “rates” regarding

ambulance service fees. Motion passed unanimously.

NEW BUSINESS

On a motion by Herndon and seconded by Rodgers, and with Herndon, Todd, Parrott, Whitnell, Jackson, Rodgers, Adams and Carr voting yea and none voting nay, Council approved on first reading **Ordinance 6-21** "an ordinance changing the name of North Industrial Drive" to Stone Drive. Motion passed unanimously.

On a motion by Parrott, and seconded by Adams, and with Carr, Adams, Rodgers, Jackson, Whitnell, Parrott and Todd voting yea and with Herndon voting nay, council approved **Resolution 10-1-21** "a resolution to provide ARPA designated premium pay to city first responders." Motion passed 7-1.

On a motion by Jackson, and seconded by Whitnell, and with Todd, Parrott, Whitnell and Jackson voting yea, and with Herndon, Rodgers, Adams, and Carr voting nay, and with Mayor O'Nan casting the deciding nay vote, Council failed to approve **Resolution 10-2-21**, a resolution "to disburse CARES Act funds to essential city employees." Resolution failed 5-4.

On a motion made by Jackson, seconded by Herndon, and with Carr, Adams, Rodgers, Jackson, Whitnell, Parrott, Todd, and Herndon, voting yea and with none voting nay, Council approved **Resolution 10-3-21** "a resolution authorizing Mayfield Police Department to contract with the Commonwealth of Kentucky, Justice and Public Safety Cabinet, Department of Criminal Justice Training in the Kentucky Law Enforcement Council." Motion passed unanimously.

Monthly reports were given by department heads and councilmembers.

With no further business to come before the Council, the meeting was adjourned at 6:11 p.m.
